## ROSTERING & DEPLOYMENT

- \*All the reaction officers' deployment is done from the office control.
- \*Rosters are done in advanced to eliminate misunderstanding and to ensure proper placement – accurate and punctual.

## IDENTIFICATION

- \*All the reaction officers have identification CALL SIGN.
- \*Other equipment's includes Anti-riot equipment, Rifles & Pistols.
- \*Uniforms are worn at all the times, EXCEPT **escorting squad**.
- \*Reaction officers are issued with two sets of uniform.

## REPORTING & DOCUMENTATION

- \*Monthly or quarterly reports are done on request or as required.
- \*ISS INKOWI provides access control register book to the clients at "**NO COST AT ALL**".

## Why appoint ISS INKOWI

### ARMED LOCAL ESCORT:

- Armed assistants can be used to safe guard the delivery vehicles loaded with client's consignments.
- All the necessary training will also be confirmed before any armed assistant will accompany the driver of a delivery vehicle.
- The armed assistant will not deliver goods or parcels together with the driver or the other assistants but will only safe guard the transport vehicle and the consignment inside.
- These people will be in possession of licensed firearms not smaller than 9mm pistol or a 38-caliber revolver.
- Armed escort will be used for any bulk collections or deliveries, which need to be safe guard on route.
- Armed escort consist of two-armed guard in an unmarked vehicle traveling behind the delivery vehicle.

- The armed escort will drive a vehicle in good condition and with an engine capacity not smaller than a 1600cc.
- The armed escort will always be neatly dressed whenever present at any of the client's sites including the client's customer sites.
- The armed escort will be in possession of cell phone or paper.

## EMERGENCY PROCEDURES

In any attempted hijacking, accident, or any other emergency the following procedure will take place:

- Response units from ISS INKOWI will be contacted.
- SAPS will be contacted by ISS INKOWI radio room.
- The clients contact person will be noticed.

## HIJACKING

\*The armed escort will notify afore-mentioned places immediately.

\*Surveillance will continue until response unit / SAPS arrive.

\*Once the response units / SAPS have arrived on the scene ISS INKOWI will take the necessary steps retrieve the cargo in terms of regulations and SAPS procedures, and firearms will only be used in case of emergency.

## ACCIDENT OR BREAK DOWN

\*Response units from ISS INKOWI will be contacted.

\* The clients contact person will be notified immediately.

\*The cargo will be secured by whatever means possible.

An authorized client's person will deal with the accident scene or breakdown.

NB: All the reaction officers has to have a valid grade 12 certificate and S.O.B minimum grade 11 certificates or report from the schools.

### **Grades:**

Security Officer, Grade A" means an employee who performs any one or more of the following duties:

- a) Advising or reporting on any matter affecting guarding or protecting services.
- b) Assuming responsibility for staff training.
- c) Guarding or protecting goods.
- d) Supervising sub

Reaction officer, Grade A" means an employee who performs any one or more of the following duties:

- a) Supervising
- b) Controlling
- c) Instructing or training Reaction officer, Grade C, D, or E
- d) To reporting thereon to his employer or may drive motor vehicle in the performance of any or all or all of his/her own duties.

Reaction officers Grade C" means an employee who performs any one or more of the following duties:

- a) Supervising or controlling security officers grade D & E
- b) May drive motor vehicle in the course of supervision and controlling reaction officer's grade d & e.
- c) May drive motor vehicle for the purpose of transporting reaction officers.

Reacting officer Grade D" means an employee who performs any or more of the following duties:

- a) Controlling or reporting to the movement of person or vehicle through checking

points or premises etc.

- b) Searching person and if necessary, restraining them
- c) Supervising or controlling reaction officers, grade E
- d) Searching goods or vehicles

Reaction Officer E means an employee other than a reaction officer grade D or more of the following duties:

- a) Guarding, Protecting or patrolling premises or goods
- b) Handling or controlling dogs in the performance of any or all of these duties.
